Accreditation Process within EuroMediterranean Area

On the 01/12/2014 Salto-Youth EuroMed received 74 accreditation requests from Tunisia, Algeria, Palestine, Egypt, Israel, Lebanon, Jordan and Morocco.

From **Tunisia** we received 14 accreditation requests and 15 NGOs took part in the Training course for Mentors and Responsible of Projects in EVS organised in cooperation with the Tunisian EMYU from 9 to14 June 2014. 13 NGO got favourable feedback from the accreditors who did the field visits.

From **Jordan** we received 16 accreditation requests and 13 NGOs took part in the Training course for Mentors and Responsible of Projects in EVS organised in cooperation with Jordanian EMYU from 2 to 7 September 2014. 10 NGOs got accreditation for hosting and sending volunteers and 1 NGO only for sending volunteers.



From **Lebanon** we received 12 accreditation requests on line¹ and 13 NGO attended the training course for Mentors and Responsible of Projects in EVS organised in cooperation with GIZ and Civil Peace Service from 11 to 15 November 2014. 6 NGOs have been accredited as Sending and Hosting, 3 only for Sending and 4 have been rejected for the moment.

From Palestine we received 17 accreditation requests and

14 NGO attended the training course for Mentors and Responsible of Projects in EVS organised in cooperation with Palestinian EMYU and Italian National Agency of Erasmus + Youth in Action from 18 to 23 November 2014. 10 NGOs have been accredited for Hosting and Sending, 1 only for sending and 3 didn't get the accreditation.

Regarding Algeria, Egypt, Israel and Morocco:

From **Algeria** we received 4 accreditation requests.


From **Egypt** we received 6 accreditation requests.

From Israel we received 3 accreditation requests.

From Morocco we received 2 accreditation requests.

The launch of the training course for Mentors and Responsible of Project is always the right tool for promoting the accreditation and for starting the process of filling in the PDF online and complete the PIC.

Regarding the PIC, some NGOs still have problems in understanding how to finalise the process and how to upload the legal identity and need many recalls from our side/us.



Training courses for Mentors and Responsible of Projects within EVS EuroMed cooperation















Training courses for Mentors and Responsible of EVS

projects have been /were realised in **Tunisia**, **Jordan**, **Lebanon** and in **Palestine**: 55 NGOs and 110 participants in total.

The accreditors visited the 55 NGOs and met the Mentors and Responsible of projects.

The training course aims to help EVS mentors and RoP's to understand more about their roles in an EVS project, as thought to answer their questions and develop their abilities about creating and managing EVS projects and mentoring volunteers; it also aims to help the participants develop tools for engaging volunteers, local communities and organisations in an educational and learning experience.

The training course is part of the EVS accreditation process in Meda Countries. Each NGO who would like to became accredited for sending or hosting volunteers should send 2 participants to the trainings organised at national level (dates are decided on basis of

accreditations' request)

The training course will tackle the following topics:

- 1) EVS structure: the principle actors, the pedagogical approaches;
- 2) Learning in the EVS process for the volunteer and the NGO
- 3) Mentors and Responsible of projects: tasks, roles, values, attitudes, and competencies
- 4) The official documents referring to EVS
- 5) Youthpass
- 6) Risk prevention and communication















The trainings and accreditation process allow to increase

the importance of the definition of volunteering in the NGOs following the different national experiences and cultures. The training provides opportunity to connect at national level NGOs and to assess the meaning and value of volunteering.

During the training, each group produced a checklist about the roles and tasks of Mentors (sending and hosting NGO) and ROP (sending and Hosting NGOs).

Open questions:

- 1) How to guarantee the sustainability of the training courses in the different countries?
- 2) In case it is not possible to do the TC in some countries, can some individual participation to international TC for mentors be supported? And in any case, we should arrange field visits.
- 3) Due to the multiplier effect of the 1st training, is there a need for a second TC in Tunisia, Palestine and Jordan?
