# Focus on "minorities in Europe"

The question of how to define 'minority' was on the agenda of the United Nations Sub-commission on Prevention of Discrimination and Protection of Minorities from the very first days of its existence (1947). Since then, numerous attempts have been made to reach an agreement on this question. Although no definition of a minority was universally recognized..... nevertheless one can observe that draft definitions, despite concrete formulations, repeat certain elements: (a) a group numerically inferior; (b) in a non-dominant position; (c) having certain characteristics (identity), culture (ethnic, religious, linguistic) which distinguish them from the rest of the population; (d) with a sense of solidarity or will to safeguard their characteristics. However, some of these elements are subjective and, as such, open to various interpretations and understandings, as the various studies carried out by the United Nations on this question show....The notion of 'minority', as implied by normative instruments, is a restrictive one and it applies only to national, ethnic, religious, linguistic groups and is not related to other disadvantage groups (women, children, aged, etc.), neither does it cover indigenous people<sup>1</sup>.

"Citizenship Matters: The Participation of Women and Minorities in Euro-Med Youth Projects" This training course address thematic issues related to the Euro-Med programme, which are equally relevant to the culture of human rights, namely women's rights, minority rights, approaches for citizenship and participation of young people. As a practical side to the course, the participants should identify guidelines for applying those principles in youth exchanges and other Euro-Med projects. The course took place in April 2004, in Alexandria, Egypt, thanks to the co-operation between the Partnership (formed by the Council of Europe and the European Commission to develop a common project on Euro-Mediterranean youth training) and the Swedish Institute of Alexandria.

## The European Convention on Human Rights

This document, which is the centre piece of the Council of Europe's normative "aquis", is also of relevance for the **protection of minorities** because its universally applicable individual rights can also be claimed, individually or collectively, by persons

belonging to national minorities. Relevant provisions include the freedom of thought, conscience and religion, the freedom of expression, the freedom of assembly and association. Within this context the **framework convention for the protection of national minorities** created in 1990 stated that: *the notion of a minority (whether it be linguistic, ethnic, religious, cultural or otherwise) can refer to very diverse situations. In particular, concentrated minorities, for which territorial solutions are possible, should be clearly distinguished from dispersed minorities, for which such solutions are evidently excluded.* The purpose of this report is to attempt to define certain types of rules on the protection of minorities which are found to exist in federal or regional States. www.coe.int/T/E/Human%5FRights/Minorities/2%2E%5FFRAMEWORK%5FCONVENTION%5F%28MONITORING%29/

Particular attention is paid to minorities within the context of the current EU enlargement process to countries of **Central and Eastern Europe**. In this context, particular attention is paid to the situation of the **Roma** communities as these populations (around 6 million people in Central and Eastern European countries) suffer from widespread prejudice and discrimination.
