## 1. FRAMEWORK & CONTEXT

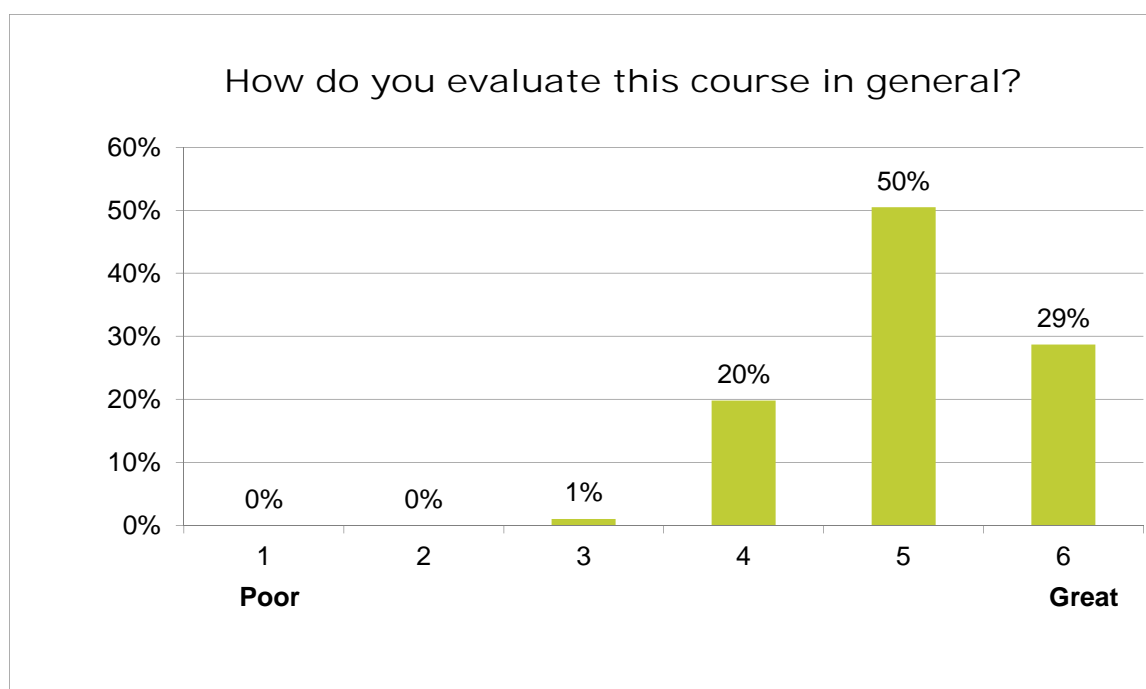

## 2. GENERAL COURSE EVALUATION

Across all five courses implemented between October 2009 and October 2010, almost 80% participants assessed the courses as having been very good or great (5 or 6 on a scale from 1–6).

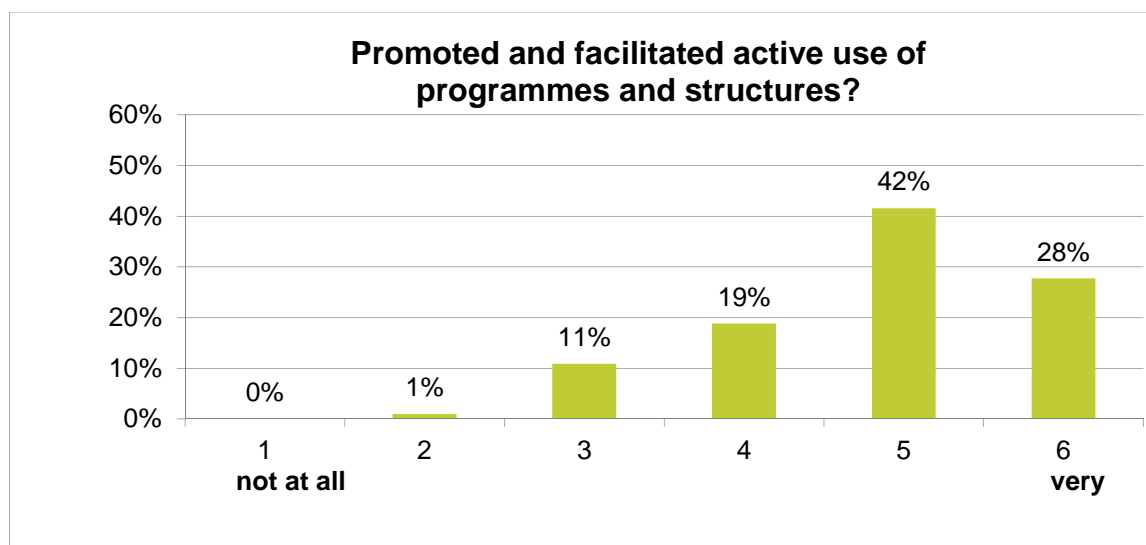
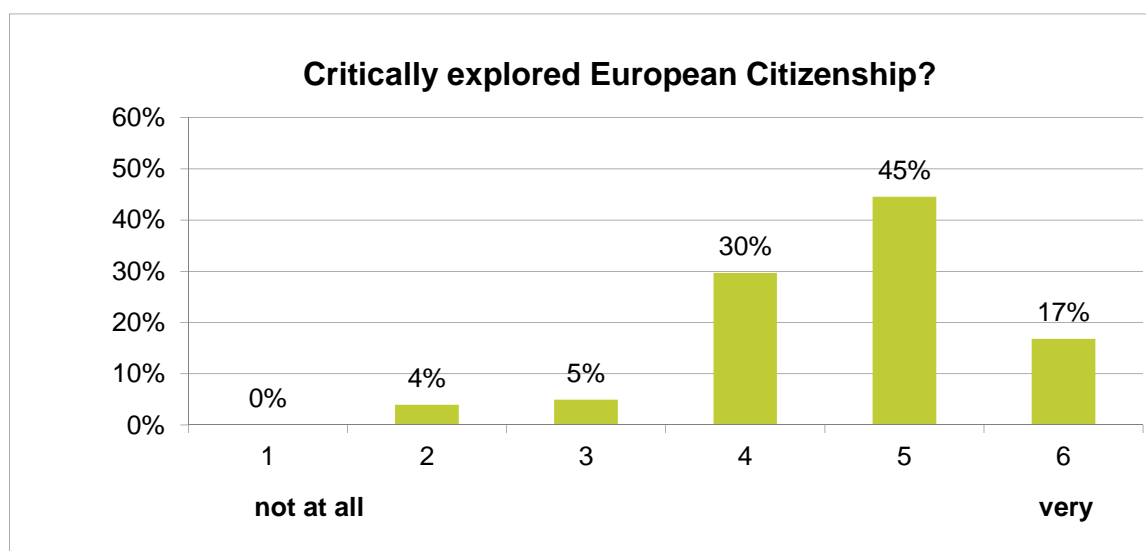


### 3. ACHIEVEMENT OF COURSE OBJECTIVES

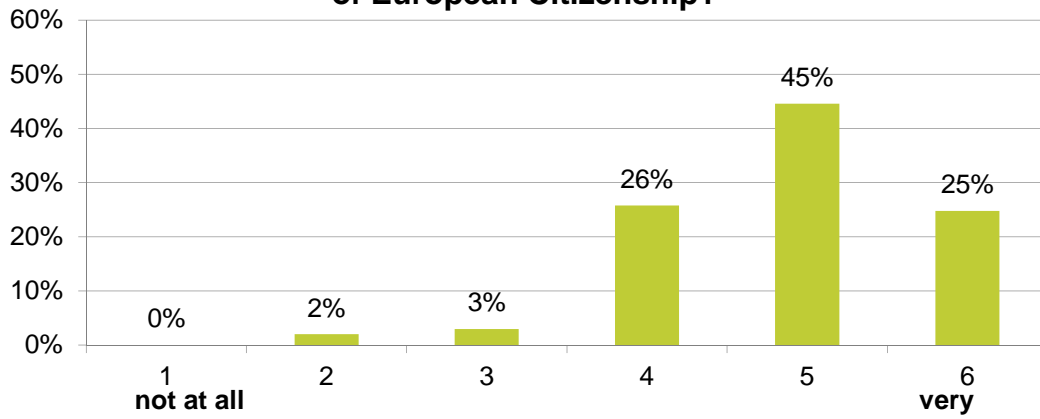
The training course has five objectives to realise and operationalise its aim of supporting the professional development of youth workers and youth leaders, namely to:

- associate the participants with the current discourse on European Citizenship (its concepts, formal meanings and expressions);
- exemplify the connection between European Citizenship, Human Rights, Democracy and Intercultural Learning and the underlying values.

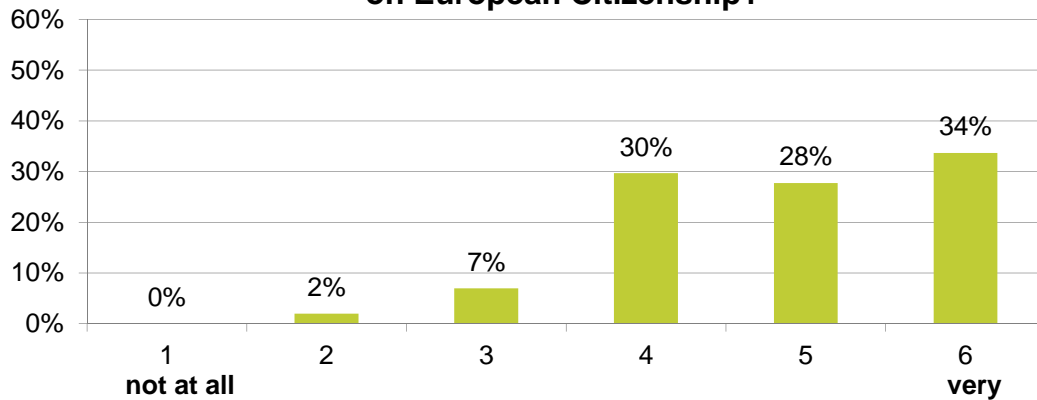
All objectives have been achieved across all courses of the assessed period, as the graphs show:



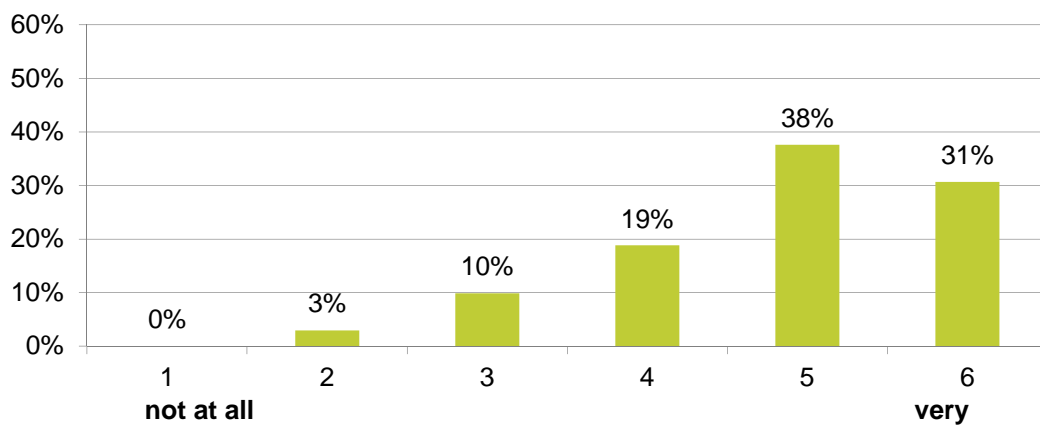
### Experimented with and explored potential of European Citizenship?



### Associated participants with current discourse on European Citizenship?



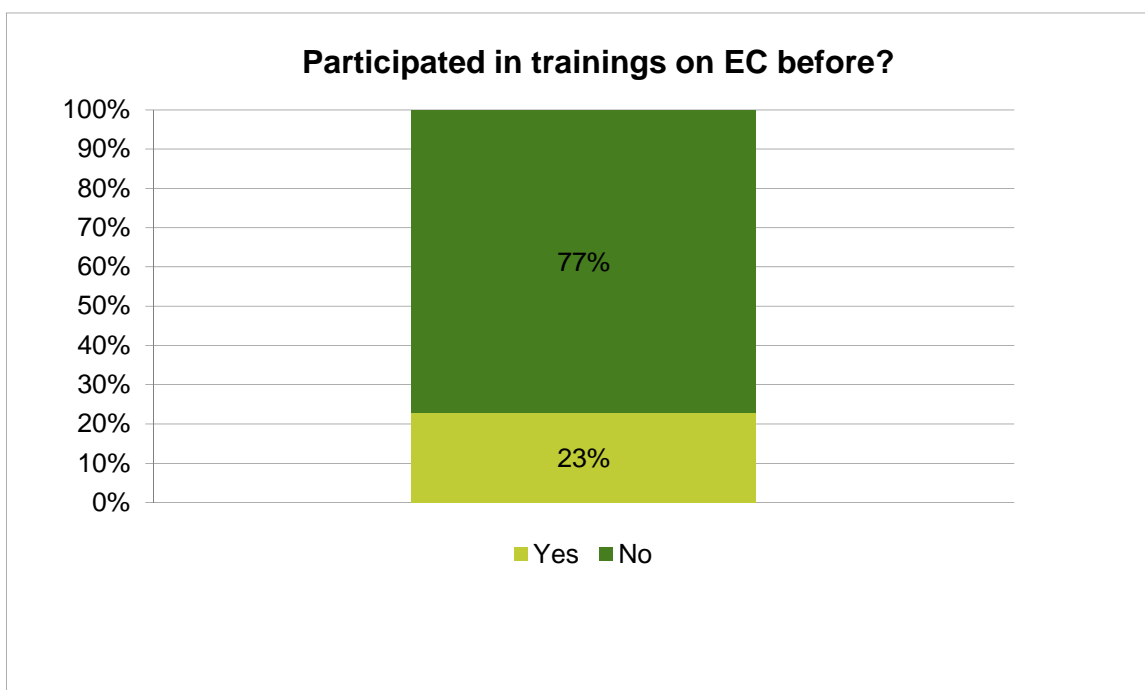
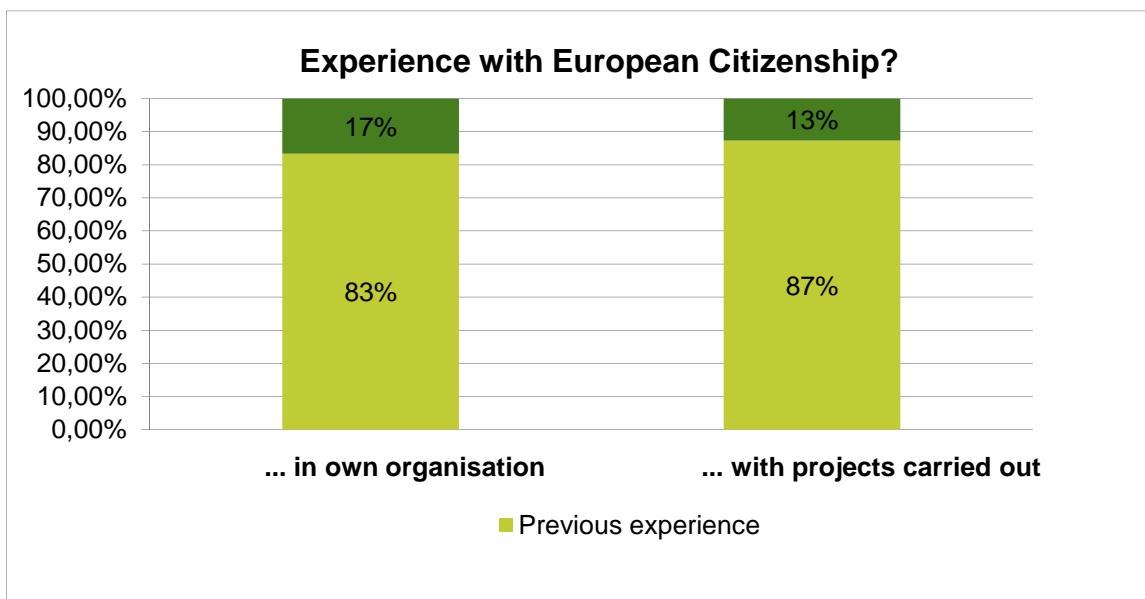

#### 4. PARTICIPANTS' PROFILE

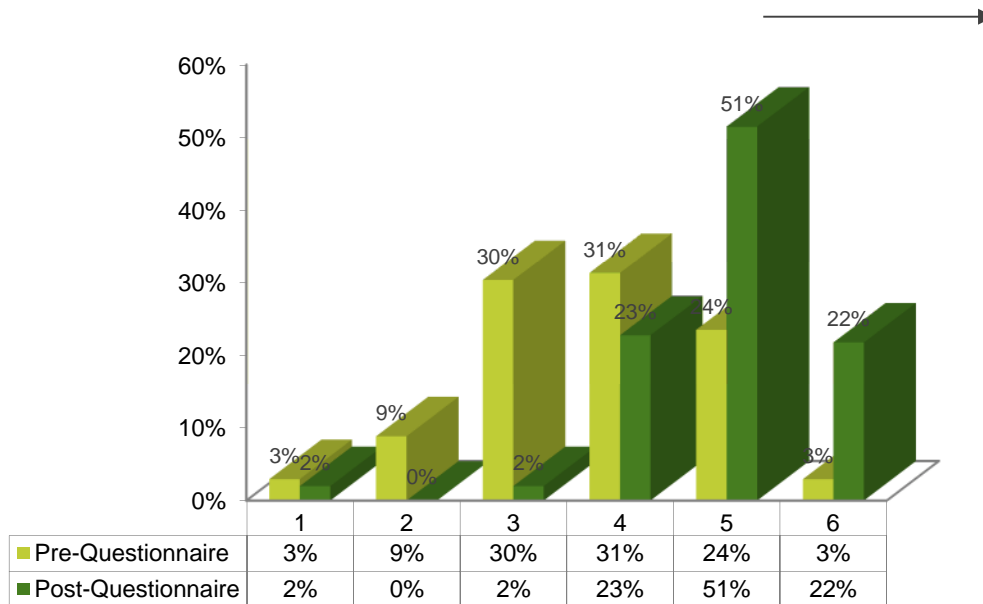
The course is intended for up to 30 committed youth workers, youth leaders and multipliers from programme and partner countries who are working with young people in a professional capacity; have experience in developing and managing projects with and for young people; have organised at least one youth project with a European dimension; are supported by their organisation in their current and future work; have knowledge of youth and youth work realities in their contexts, and are committed to work with young people on issues related to European Citizenship.

Most participants have not undergone training on European Citizenship previous to attending a network training, but have experience with projects as well as discussions in their own organisations around the topic:

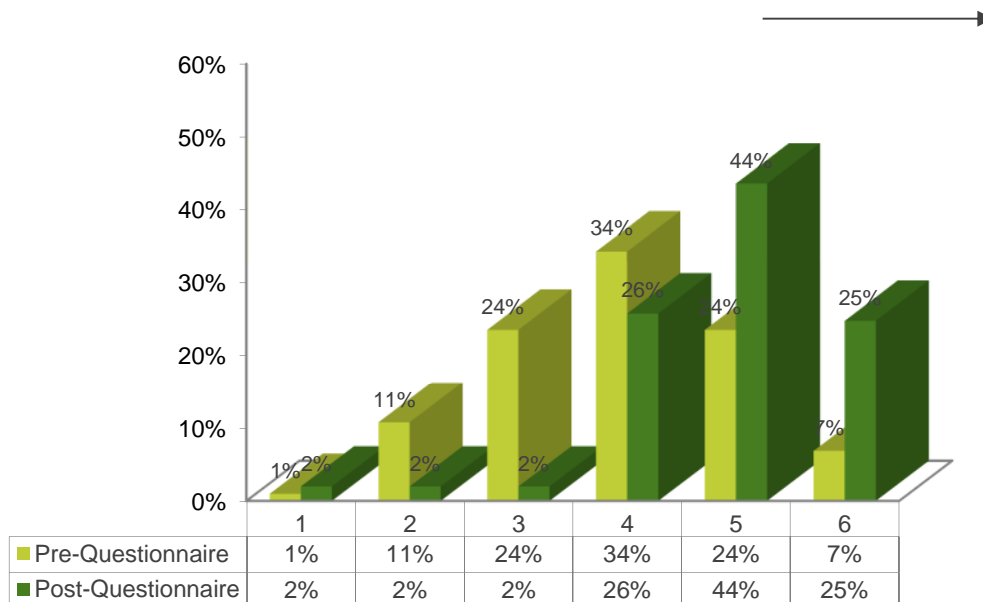

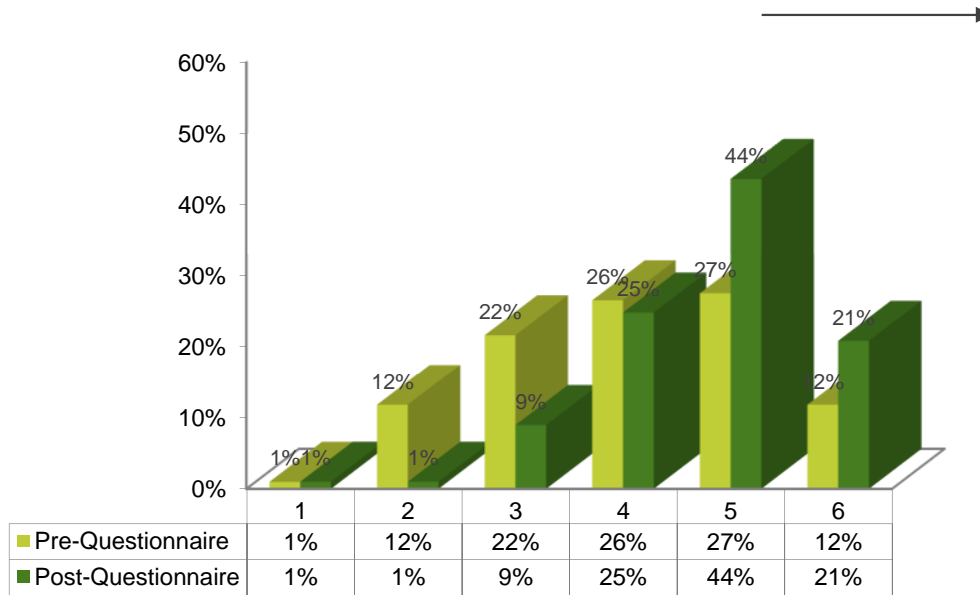
### Familiar with concept of European Citizenship?



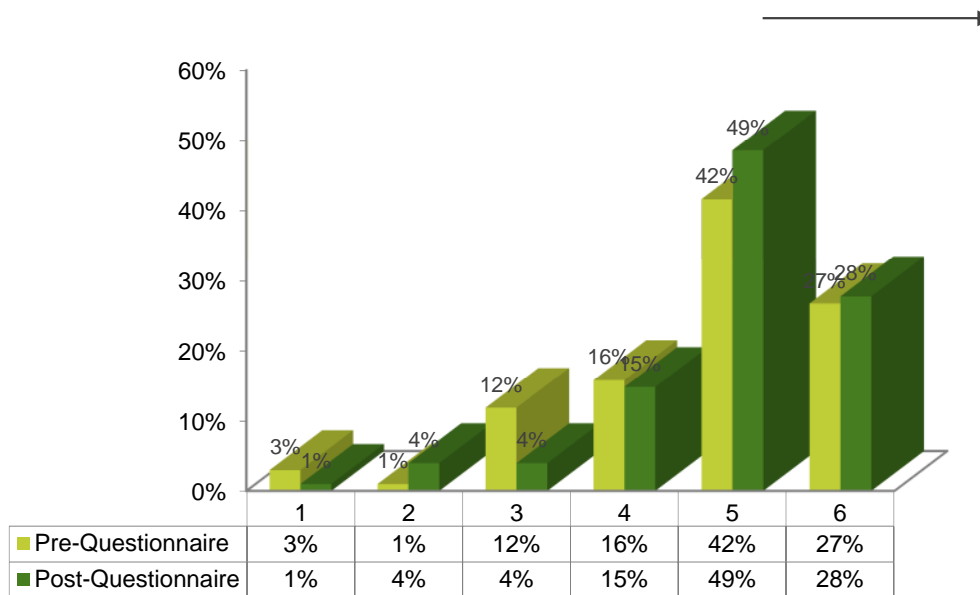
### Confident to promote European Citizenship in own environment?



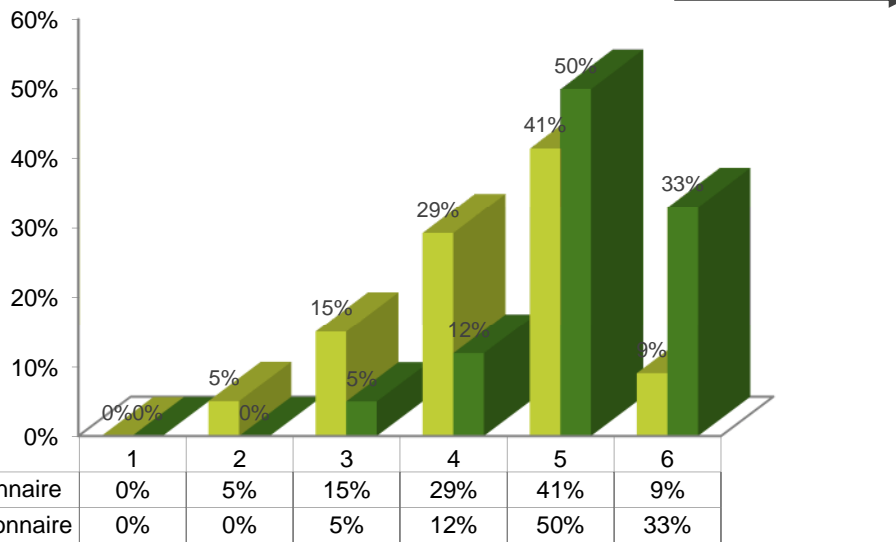
### Confident to promote European Citizenship to unknown youth?



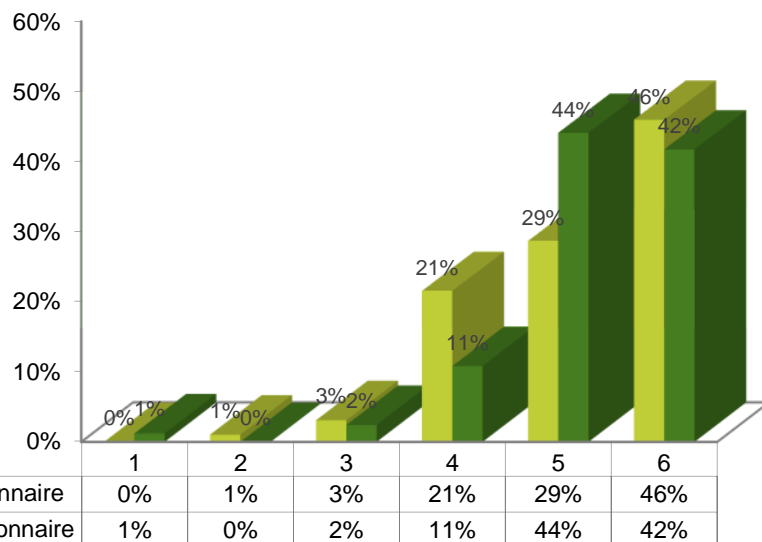
### Confident to communicate in international environment?

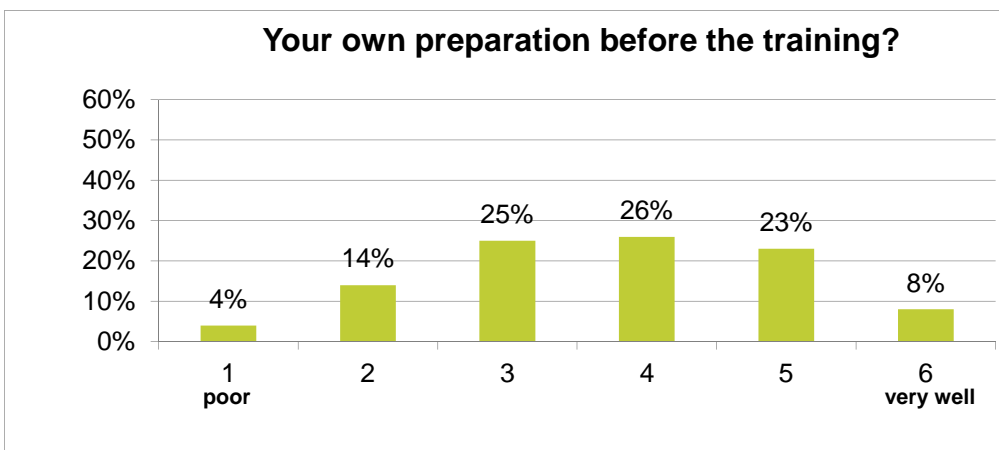
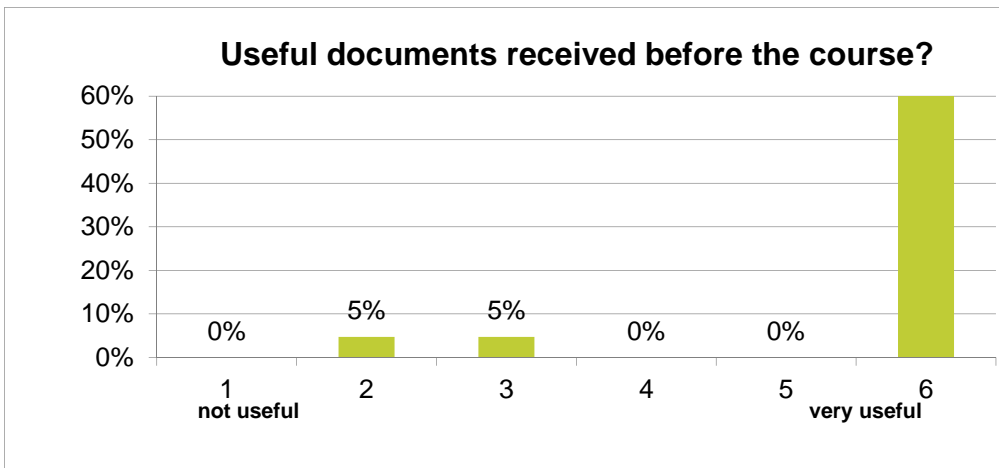
