


A new Programme for <u>all</u> young people...

- promotes the young people's active citizenship (such as Europe for the citizens, Culture, Media...)






... with a strong ambition


- supports numerous concrete projects, while taking care of the structuring effect of these initiatives



Lessons from the past

- Contribute to the development of the youth organisations and support the "youth workers"
- Be more open to third countries
- Contribute to the recognition of the activities supported by the Programme
- Propose simple and flexible procedures in view of the target public

- New actions, previously tested as pilot projects




- Global envelope: 885 MioEUR 2007-2013






What changes in Youth in Action?

- Cooperation in youth policies














Age limits

- => Inclusion strategy






Important Features of the Programme

- Supportive approach






Important Features of the Programme



Dissemination and exploitation of results:

- micro level (targeting young people, project participants, partner organisations, local communities...)
- meso level (targeting youth organisations and other bodies active in the field of youth, youth workers and other multipliers...)
- macro level (national and European decision makers...) feed policy developments with project results






Actions of the Programme

- 1.3 Youth Democracy Projects (new)






Action 2: European Voluntary Service



- One single EVS (independent of individual or group character, application level or geography)
- One project can include individual and/or group EVS activities
- International cooperation with Partner Countries is possible within EVS






Action 4.3: Training, Exchange, Networking in the youth field

- Supporting project-development under the Youth in Action Programme








Programme Management



- Executive Agency : 15%
- National Agencies : 85%
- Permanent Call for proposals (Programme Guide) : Executive Agency and National Agencies
- Calls for proposals : Executive Agency
- Fixed amounts and lump sums largely used



* also for projects selected at European level






Programme Guide








Implementation



- Most of the actions are implemented at both centralised (EACEA) and decentralised levels (National Agencies)
- The centralised level is dealing with applications from organisations represented in at least 8 Programme Countries
- The decentralised level is dealing with more « national-based » organisations
- In addition to the Executive Agency and to the 33 national Agencies, the Programme also has two other types of structures with more targeted objectives:
 - SALTO-Resources centres (thematic training and support to NAs)
 - Eurodesk information centres (information to Young people and Youth stakeholders)




