It focuses on strengthening young people's access to rights, deepening their knowledge, and developing their

STUDY SESSION

This study session focuses on two of the five strategic priorities of the Council of Europe youth sector:

Revitalising pluralistic democracy and Young people's access to rights.

The activity aims to contribute to the quality development of participatory youth structures by building the

capacity of members of local youth councils (LYCs) and similar bodies across Europe. The role of LYCs in

shaping youth-based policies, promoting democracy and youth rights, and fostering intergenerational

dialogue is increasingly recognised. By strengthening their policy and advocacy competencies, this study

session will empower young people to effectively represent youth interests and take an active role in

democratic processes at the local level.

The long-term goal is to provide a comprehensive framework of standards and tools that support the

participatory, inclusive, and sustainable functioning of local youth councils. Through this, young people will be

better equipped to advocate for youth rights and participate meaningfully in local governance, enhancing

both democratic culture and youth empowerment in their communities.

### **OBJECTIVES OF THE STUDY SESSION**

This study session will gather 20 young people involved in local youth councils and youth policy advocacy to engage in a programme based on the principles of non-formal education, intercultural learning, and participatory methods. The programme will combine theoretical and practical elements, giving space for exchange, co-creation, and mutual learning.

The specific objectives of the study session are to:

- Mainstream local youth councils as spaces for quality and inclusive youth participation at the local level
- Build the capacity of local youth council members in the areas of youth policy and advocacy
- Explore tools and resources such as the Quality Charter on Participatory and Inclusive Local Youth Councils, its User Guide, and Toolkit developed by DYPALL Network
- Foster collaboration and networking among local youth councils from across the Council of Europe countries
- Enhance intercultural understanding and promote a shared sense of European unity

The study session will also contribute to broader initiatives promoted by the Council of Europe and its partners, such as the Have Your Say! manual, the Youth Policy Essentials MOOC, and the Shaping Youth Policies in Practice project.

## PROFILE OF PARTICIPANTS

The Study Session is targeting:

- Members of local youth councils or similar youth participatory structures at the municipal level
- Young people actively involved in youth policy-making or youth advocacy at the local level
- Participants who are between 15 and 25 years old
- Participants with a strong interest in youth advocacy and policy, and motivated to build their capacities to effectively represent youth in democratic processes

Moreover, participants must:

- Be able to work in English, the working language of the study session
- Be residents of Council of Europe member States, or Belarus, Holy See, or Kazakhstan
- Be available to attend the full duration of the study session

- Be committed to implementing follow-up activities in their communities
- Have experience with or plans for strengthening local youth councils, especially in cooperation with local authorities

We welcome applications from all candidates who fulfil the above-mentioned criteria, irrespective of gender, disability, marital or parental status, racial, ethnic or social origin, colour, religion, belief or sexual orientation.

### PRACTICAL INFORMATION

#### Travelling days and expenses

- Arrival day is 23rd November 2025 (preferably by 6 pm), and departure day is 29th November 2025. The arrival and departure airport is Strasbourg airport or other airports in the surroundings (e.g. Paris, Frankfurt, Basel) that offer train/bus connections to Strasbourg
- Flight tickets and any other tickets shall be bought only after confirmation from the organisers.
  Travel expenses to and from the venue will be fully reimbursed according to the Council of Europe's rules
- The **enrolment fee** for the study session is 50 EUR per participant. The fee is deducted from the refund of the travel expenses
- Visa costs will be reimbursed by the Council of Europe. The Council of Europe secretariat will issue an invitation letter that should facilitate the delivery of visas to attend the study session
- Accommodation and meals will be provided by the organisers in the European Youth Centre in Strasbourg. Please note that the accommodation will be provided in double rooms with a private bathroom
- **Green transportation** is encouraged (such as by train or bus), especially for travels that take less than 12 hours.
