### **Participants:**

Study Visit will bring **26 participants**, 13 experienced youth workers from [Program Countries](#) (i.e. EU and EFTA member states, Turkey) as well as 13 NA’s officers (i.e. representatives of the National Agencies of the Youth in Action Program). In the best case a national pair composed with each profile. National Agencies are invited to spread the call at national level and to select the youth worker that will participate in the Study Visit.

### **Applicants' Criteria for youth workers:**

- are representative of the youth organization or organization working with young people, whom are able and authorize on behalf of its organization to create future projects ideas
- have basic knowledge about the Youth in Action Program (experience in projects with EuroMed countries is very welcome)
- have experience from minimum 1 international youth project which was realized within the Youth in Action Program (other non-formal education experience will be an additional advantage)
- are prepared to participate in follow-up or evaluation activities organized by the National Agency or SALTO-YOUTH network
- are prepared to actively attend and contribute during the full duration of the Study Visit
- have ability to communicate in English- Knowledge in French will be an additional advantage
