FULL DESCRIPTION OF TRAINING CONTENTS

IN THE LANGUAGE OF THE TRAINING: (EN)

Preparation* The participants will be expected to have a basic knowledge on the pillars of sustainability (environmental / social / economic) and delicate ecosystems (islands and the sea / rivers). It is recommended that prior to arrival the participants read up on the topic. A list of light, suggested reading will be passed on to the participants upon approval of application. These articles will explain the basic concept of the topic of the project. An example of articles include: Beyond the Pillars: Sustainability Assessment as a Framework for Effective Integration of Social, Economic and Ecological Considerations in Significant Decision- Making.

A registration form will be put up online for the participants to fill in upon applying, to register and present themselves to the training team.

The participants will also be asked to translate and disseminate a questionnaire which we will be preparing for them, to the general public in their countries prior to travelling to Malta. The purpose of this is to gain an idea of the level of awareness of the general public about sustainability and maintenance of the environment in the nations of the participants.

The participants should also become familiar with the host environment.

The course will be held in English, and the language of communication in Malta will be English, it is important that participants have a good command of the English language. English lessons should be considered if necessary.

Objectives* Through this project, the participants will become more aware of the different pillars of sustainability and assess the level of awareness of this topic in their countries. They will discover and experiment with different methods of sustainability in an international arena where different ideas can be shared. The participants may then go back to their home countries and implement these new ideas and concepts in their own businesses or pass these ideas down to their pupils or peers.

This course aspires to reach the above aims through the following objectives:

- 1) To create awareness about the visible and invisible threats to the environment.
- 2) To inform people on current methods being implemented to protect, maintain and restore the environment.
- 3) To touch and view these hazards through onsite visits in recycle plants and companies tackling environmental maintenance.
- 4) To tackle the fact that adults did not have this sort of information in their primary and secondary schooling and that they too need to be informed.
- 5) To increase networking and international - intercultural cooperation between the sending organisations and their European networks.
- 6) To learn alternative ways of teaching / learning about sustainability and the environment.
- 7) To learn about organic farming, sustainable fish farming and sustainable fishing and husbandry.
- 8) To learn about the LLP and its 8 key competences.

Methodology* This course will be making use of several different methods in order to complete its objectives; Namely:

- 1) Peer participation - This will be used in the preparation part of the course where the participants will be asked to conduct research in the form of a questionnaire which will be sent to them by the hosting team. The participants will be asked to collect some information on the knowledge of their peers about the topic of this course. They will then be asked to share this information with the other participants during the course. A data analysis of the results will be conducted in order to assess the problems in each country. Varying results will create room for a more in depth study.
- 2) Formal education methods will be used as a number of professionals will be visiting the participants to give a lecture/talk.
- 3) Hands on activities will take place in the form of physical activities that the participants will be asked to be a part of such as hikes etc.
- 4) The participants will be taken on on-site visits. These will be not only to certain areas of the island that display different aspects of the pillars of sustainable environment, but also to the largest Sustainable Environment Development Center on the island.
- 5) The course will involve a mix of non-formal and informal education methods. This will be due not only to the experience that the participants will be gaining from being in a foreign country, but also from certain activities that are due to take place such as debates and the pooling in of ideas between the participants coming from different countries.
- 6) Evaluation will be an ongoing process commencing from the acceptance of applications and will hopefully continue even after they are back in their countries in the form of dissemination. During their stay on the island, evaluation will take daily. This will take place in written and oral forms. It questions the contentedness of the participants about the course content and comfort logistically.

Follow-up* The follow-up of this course includes:

- 1) The sharing of contacts between the participants and the trainers. The participants will be creating new contacts and creating a network with each other where they will be able to share information with each other about the subject.
- 2) A website will be created where the conclusions of the courses can be published. This website will

be linked to the website of the sending entities and the stakeholders and will be shared with all participants, who will then be able to share it with their own peers and contacts.

3) The conclusions will also be sent to the participants individually to disseminate as they please.

4) This course can/may lead to more strategic partnerships and projects.

5) The participants will have developed new means of self-evaluation of the lessons they have learned throughout the course which they may then implement in their daily lives in their own countries.
