about

2018 unmasked new threats to democracy, human rights and rule of law - three main pillars that guarantees sustainable and peaceful Europe. It was reported that online private data can be breached and misused to affect major geopolitical decisions on one hand, and a well-being of every individual citizen on the other hand.

Unprotected citizen on the internet can easily become prone to exposure of hate speech, extremist content, narratives that undermine the values of human rights and peace. This project aims to create a practices of youth resilience building and education for cyber hygiene by providing, practicing and disseminating the relevant tools in youth work in partner organisations.

This project is supported by the German National Agency - Jugend fuer Europa under the European Union programme Erasmus+ - activity - mobility of youth workers.

This project is coordinated by Youth Association DRONI and East-West-East Germany e.V.

goals

- To raise risk awareness in youth workers on individual and organisational levels;
- To give tools on how to identify, mitigate risks and build resilience;
- To inform about the international covenants protecting human rights online and explore the mechanisms of its use,
- To create a space for their adaptation for young people;
- To explore how internet can be connected to democratic citizenship and human rights;
- To train youth workers in steps for data protection, security, report mechanisms and equip them with educational tools for internet literacy;
- To multiply the effect through educational activities for and with young people at the partner organisations provided by the participants;
- To promote cyber hygiene through creating and disseminating booklet and creating training modules for young people;
- To create an educational pack of tools to be used with young people, and disseminate it in the organisations working with young people;
- To increase educational and mobility opportunities via training youth workers in project development and management.
- To create practices of organizational cyber-hygiene within youth organizations

activities

PHASE 1.0 - *Training Course in Tbilisi, Georgia.*

2-6 XII 2018 participants will get to know the basics of cyber security, get inputs on big data, data harvesting, microadvertising and reflect on its consequences on democratic society. On the other hand, they will focus on creating methodologies to educate young people in their local context.

PHASE 2.0 - *Intermediate phase -*

XII - III 2.1. Goal setting - participants and project team will set indicators and objectives beforehand, to make sure there's a quality standard for every intermediate phase activity. Participants have to meet minimum requirements of the hours and human assets in order to have potent impact on the local level.

2.2. Coaching sessions - each trainer will be assigned to the participants and mentor them throughout the intermediate phase on designing, preparing and evaluating the activities.

2.3. Action! - participants will implement educational activities for and with young people.

2.4. Report - participants will evaluate and report their activities to the project team based on online form.

2.5. Massive Open Online Course - Erasmus+ Funding Opportunities for young people, participants have to complete the course as a homework.

PHASE 3.0 - *Seminar in Welper, Germany*

26-30 III 2019 3.1. sharing and evaluating the intermediate phase results;
3.2. creating a booklet for young people and organisations on how to become cyber-hygenic;
3.3. creating session outlines of the non-formal education-based activities on cyber security;
3.4. piloting the sessions with the local youth;
3.5. generating new Erasmus+ projects.

PHASE 4.0. - *Taking the steps further...*

4.2. Participants implement cyber security protocols in the organisations;
4.3. Participants finalise the youth passes;
4.4. Questionnaire on project evaluation is sent to the participants;
4.5 Impact Assessment sheet is sent to the partner organisations;

HOTEL

You will be sharing rooms with 2 or 3 persons, the linen and towels are provided in the rooms, the hotel usually provides soap and shampoo but not the best quality;

VISA:

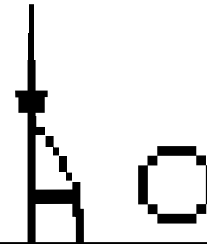
The visa is not needed for the participants unless you are not the resident of the sending organizations' countries, in this case, please do contact the coordinator.

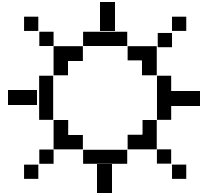
MISC:

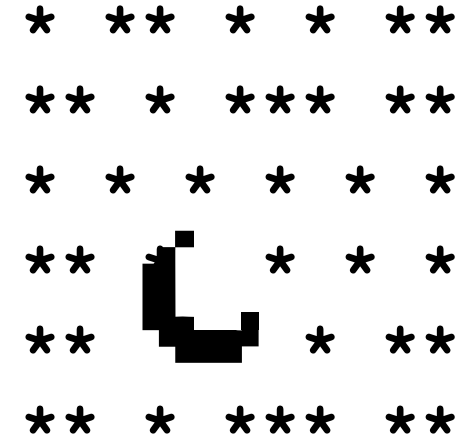

Germany - 530 EUR

Estonia - 360 EUR

Georgia - 20 EUR
