## PARTICIPANTS SHOULD DO

- To search and inform project coordinator about travel tickets and buy them **AFTER GETTING CONFIRMATION** from them.
- To inform the hosting organization about the time of arrival and ensure attendance to all sessions of the project activity.
- Obtain the health insurance. It is mandatory to arrange one in advance before coming to the project.
- Prepare for the project in advance and disseminate outcomes after the implementation.
- Response e-mail within deadline.

**Private Health insurance is Mandatory** for ALL participants and should be presented upon the arrival.

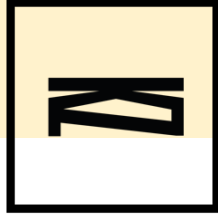
The following areas must be covered:
