2/ ELIGIBILITY CRITERIA

- ✓ Be available for the entire **duration of the training** (02/02-04/02/2022)
- ✓ Be available to support as trainer during **at least one of the We4Change Events** that will be organized by the sending organization in the period March–August 2022 (volunteer contract)
- ✓ Have a **B2 English level** (the training is organized in English)
- ✓ Have **previous experience in working with youth** in The areas covered by the We4Change project (climate change, digital skills, youth empowerment, entrepreneurship)
- ✓ Be a resident in one of the following countries: **Belgium, France, Greece, Moldova or Portugal**.

3/ SELECTION PROCEDURE

All applications must be submitted via the application form available at: <https://bit.ly/3FoveZA>, before the 10th of December at 23.59 CET.

By submitting the application, applicants recognize to be aware and agree with the eligibility criteria and practical information shared for this call.

The applications will **be evaluated in the period 13-16 of December** under the following selection criteria:

- Motivation of the applicant on relation to the objectives of the training;
- Relevance of the applicant's previous experience in the field of youth work;
- Availability to support as trainer during at least one of the We4Change Changemakers Events that will be organized by the sending organization

Following the eligibility check and the evaluation process, **the selected participants will be announced on the 17th of December** in order to organize their participation to the training in Brussels.
