


Gender Equality at Work


KA 1-MOBILITY OF YOUTH WORKERS

Comité de Liaison Diagonal France and Youth Association Droni are organizing a one week training, between November 27th until December 4th, on the topic of Gender Equality at Work. The aim of this project is to make participants more aware and able to mainstream gender around them and in the workplace. During the week, participants will take part in different workshops and learning visits in Tbilisi. They will then create an outcome in relation to the project.

This project is entirely funded by Erasmus+. Accommodation, catering (3 meals + 2 coffee breaks) and travels are covered for the duration of the stay. Participants should buy their tickets by themselves and will be reimbursed during the mobility.

Objectives:

- Learn how to use a gender reading grid to better identify discriminations, inequalities, gender gaps and stereotypes.
- Implement better communication at work and with the public.
- Define gender-oriented goals and targets for the workplace, put on gender lenses and adopt a gender-aware perspective in everyday work.
- Monitor progress and promote gender-aware behavior among staff, in order to create equal, respectful and peaceful work relationships.
- Make a diagnosis of equality achievement and formulate guidance for the workplace.




The deadline for applications is the 25th of September.

27 NOVEMBER - ARRIVAL DAY

Participants must arrive on November 27th or early morning of the following day.

Transportation details from the airport to the accommodation will be given once participants have their flight tickets.

NOVEMBER 28TH DECEMBER 3RD- TRAINING COURSE

The training course starts November 28th, at 10:00 AM and lasts until December 3rd, 18:30 PM.

4 DECEMBER - DEPARTURE DAY

Participants are expected to leave the venue after breakfast.




ACCOMMODATION

CONDITIONS


Regular tickets:

Participants must imperatively bring the original invoice, a proof of payment and their boarding pass. Prices on receipt/invoice must coincide with the price on the ticket.

E-tickets:

Participants must send their e-tickets with their name, price of the fair and details of the flight on the same page. They must provide a proof of payment (credit card receipt or bank statement). At arrival, they must imperatively give their boarding pass.

Reimbursement will be made by bank transfer or possibly in cash in euros, during the mobility and according to the following conditions:

Health insurance & Covid


Participants need to have a health insurance and are responsible for their own travel insurance. They should also bring their medicine and masks if they need them.


Starting June 15, 2022, all foreign citizens using any mode of travel (by air, land, or sea) to enter Georgia are exempt from the obligation to produce vaccination certificates or negative PCR test results.


