# In what way is the project innovative and/or complementary to other projects already carried out by your organization?

**SEKSEK** is a project under Human Rights, about Child Rights. Children are learning their rights while playing games and with non-formal activities.

**Keeping the Youth Away From Crime Project**; If the child is exposed to violence and/or abuse at home, the ultimate result for the child is to run away to streets where he finds gangs and commits crime. The international symposium arranged to draw attention to this issue, named "Does anyone hear me?" resulted with a manifesto for government, NGOs, families and society and this manifesto is published in the website of YVA. Project Partners France, Romania, Greece, Lithuania, Bulgaria, Moldovia and Turkey.

**Workshops for Project Improvement**, Youth Volunteers Association support youth for new project ideas. YVA arranges info days for youth who **have** ideas for social status, local, regional, national and international scales of projects, helping youth to find budget for those projects. Also YVA gives free consultancy for writing projects which will enable and increase equality of opportunities throughout society.

#### Do you have any idea regarding the programme of activities?

Turkey and Turkish civil society representatives are all aware of the hate speech results and pained by it in different ways. Polarization between different segments of society is becoming more pronounced and intolerance more widespread in Turkey. There are some specific examples like Hrant DİNK. The main problem is the discrimination, racism, intolerance in language is getting more and more widespread in Turkey. Not only the hate speech against different sects, religion groups, thought groups, political and social groups, but also to the refugees and Syrians, immigrating to Turkey.

Also another problem is the hate speech in Europe against Turkish minority groups and muslims. Especially after the war in Syria, the refugees use the way throughout Turkey to Europe, so Turkey is the buffer region/zone between Syria and Europe. The hate speech activities are mainly focused on written and visual media and as well as social media with hatred expressions and actions.
