Background and Experience		

Please briefly present the partner organization.

"EU Go Association" is a non-governmental, non-profit organization established in 2022 in Kaunas. Its mission is to support the personal and social development of youth through non-formal learning methods.

The Association aims to promote diversity, social inclusion, human rights and equality of opportunity by developing a civic and cultural identity. It provides psychological practices to improve communication, relational, emotional, digital, entrepreneurial, and leadership skills of youth. Additionally, it aims to raise awareness of the importance of environmental, social and economic sustainability.

EU Go Association also strives to introduce intercultural, non-formal education to enhance physical and mental health, active citizenship, and mindfulness among Lithuanian youth. It seeks to integrate young people into the labor market by teaching them transferable skills for successful employment and develop a sense of belonging to EU values through international mobility projects, especially within the Erasmus+ program.

Through intercultural education, EU Go Association promotes tolerance, acceptance of cultural differences and personality traits, gender equality and the exchange of cultural values in mobility projects.

EU PROJECTS IN THE LAST 3 YEARS:

Would You Survive? KA152-YOU - Mobility of young people

'Would You Survive?' was a dynamic and interactive youth exchange aimed at enhancing the knowledge of disaster management and survival skills for 30 young people from Bulgaria, Czech Republic, Lithuania, Romania and Slovakia.

The project's theoretical aspects focused on understanding how these participating countries address natural and man-made disasters across all main stages (Preparedness, Response and Recovery), along with designing emergency plans suitable for diverse scenarios and situations.

The practical approach included learning to construct strategic shelters in the forest, preparing emergency kits, igniting fires using fire steels, creating water purification filter devices, maneuvering canoes, performing CPR and essential life-saving techniques, providing psychological help to prevent and manage panic attacks, tying different types of knots, creating masking nets, and successfully navigating the forest. The main non-formal learning methods used were brainstorming sessions, group presentations, experiential learning ("learning by doing"), simulations, role-playing and outdoor activities.

What are the activities and experience of the organization in the areas relevant for this application?

The members of the EU Go Association have participated in youth exchanges and training courses under the Erasmus+ Programme. Some of the projects they have been involved in include:

- Fethiye, Turkey: Active Youth Democracy A youth exchange focused on youth solidarity and active citizen involvement, which is one of the priorities of the Erasmus+ programme;
- Murzasichle, Poland: *Youth in Touch* A youth exchange aimed at improving soft skills;
