#### Who We Are:

The Association for Migrant Rights and Social Cohesion is a non-governmental organization established in 2017 and plays a pioneering role in the field of migration. The Association carries out effective work to increase the social cohesion of migrants and carries out projects at national (Turkish Ministry of Youth and Sports, Turkish Ministry of Culture, Turkish Ministry of Interior) and international (ECHO, IOM, Erasmus) levels.

Our association organizes workshops and workshops that contribute to their personal development, increase their well-being, improve their capacities, increase their digital competencies, and contribute to their life skills in order to understand the challenges faced by migrants and offer solutions. These activities aim to increase migrants' interaction with local communities, improve their language skills, provide vocational training opportunities and contribute to cultural partnership. As an association, we offer resources and guidance to support and strengthen the social cohesion of migrants.

National and international projects are one of the most important fields of activity of our association. Various projects on migrant rights, integration, education and employment are carried out and successful results are achieved. Our projects are designed both to address the problems faced by migrants and to produce more comprehensive solutions in cooperation with local, national and international stakeholders.

Migrant Rights and Social Cohesion Association is a member of the 'Civil Society Advisory Board of the Ministry of Interior of the Republic of Turkey', which includes 40 NGOs selected among more than 140 thousand NGOs and foundations in our country. GÖÇDER participates in monthly planning meetings organized at the ministry and conveys its views and suggestions on civil society and migration to policy makers.

In line with the principles of human rights and universal law, to ensure the solution of the problems and social cohesion of individuals who are the subject of internal and external migration for different reasons.

#### Please briefly present your organisation

GÖÇDER is a non-profit, non-governmental organization that carries out non-discriminatory activities based on gender equality and in line with the principles of human rights and universal law.

The target group of the project activities are foreigners who have applied for international protection or have a status, persons under temporary protection (migrants, refugees, conditional refugees, persons subject to subsidiary protection procedure, persons under temporary protection, stateless persons, etc.), as well as individuals within the scope of internal migration. GÖÇDER aims to conduct research, develop, implement and guide solution strategies, carry out social cohesion activities, develop national and international policies and projects in this field and inform the public in line with the definitions made for different countries within the framework of United Nations conventions.

GÖÇDER aims to work with local and migrant children and youth, especially disadvantaged ones, and to carry out social and cultural activities to ensure their social cohesion through projects carried out both locally and internationally. In addition, it also aims to provide the necessary human resources and volunteer support by cooperating with national and international disaster organizations in sudden migration movements that occur in humanitarian crisis situations such as war, floods and earthquakes. It aims to support children born in new settlements to live with their old cultural values and maintain their local culture, to work with internal migrants trying to hold on to urban life in this context and to strengthen the capacities of these associations.

What are the activities and experience of the organisation in youth work and youth participation? Please also provide information on your organisation's / group's regular youth work activities.

Our organization has a wide experience in youth work and social cohesion projects and carries out national and international projects aimed at developing leadership, entrepreneurship and social skills of young people. Through trainings, seminars, social responsibility projects and cultural events, we especially support the integration of migrant children and youth into society. Through these projects, which encourage the active participation of young people, we aim to strengthen social cohesion between the local community and migrants. We organize various Erasmus+ projects and other funded activities to empower disadvantaged groups and increase the sensitivity of young people to social issues.

In 2018, we carried out protection, social cohesion activities, counseling and guidance services for migrant children with the donor organization "Save The Children".

In 2019, protection and social cohesion activities for migrants were carried out with ECHO.

In 2021, protection and social cohesion activities for migrants were organized with IOM.

In 2021, in cooperation with the Ministry of Youth and Sports, games, workshops, cultural and nature trips, sports activities and trainings to increase individual capacities were organized to increase the unity between migrant children and local children.

In 2021, within the scope of the Ministry of Interior's Migration Conflict Resolution Project, workshops, games, sports events were organized to increase social cohesion levels; field studies and workshops were carried out.

In 2021, within the scope of KA220 YOU, workshops, trips, sports activities were organized to increase social cohesion levels and support individual capacities.

In 2023, mobility activities and collective participation events were organized within the scope of KA154 YOU to support the active participation of young people in life.

In 2023, within the scope of the Ministry of Interior's Project on Increasing the Social Integration and Capacity of Earthquake Victims, Migrants and Local People, various psychosocial workshops, mapping of services they can access and motivational festival activities were organized for the target group.

Please briefly present the young people actively involved in the preparation and implementation of the project, the profile of the young people, their experience and their responsibilities in the implementation of the project. Please describe also how these young people came to be involved in the project.

The young people actively involved in the preparation and implementation of the project are generally between the ages of 18-30 and are interested in digital skills, social cohesion, teamwork, strengthening communication skills, intercultural interaction, developing leadership skills and social solidarity. These young people have previously worked as volunteers within the organization, have organizational skills and have gained experience in project management. Thanks to their experience in past projects, they have the skills to take on responsibilities such as workshop planning, project execution and direct communication with communities. In this process, they participated in the project thanks to the calls made by the project team and their success in previous projects.

In the project, each young person will assume specific responsibilities. For example, they will be involved in coordinating mobility activities, maintaining regular contact with participants, developing event content and managing social media accounts. These roles will help young people to develop both project management skills and teamwork skills.
