Organization has 520 large families with more than 2000 children and youngsters.

Organization is running anti-powerty, social inclusion, anti-violence, cultural, active citizenship and other programs and projects.

Youth of organization is very active and interested in different types of arts, music, drama, cultural education. Many of our youth members have different skills such as: music, sport, human resources, art, literature, dance, etc. In 2009 we started to work in Youth Programme and we took part in several youth exchanges, we also took part in several national training courses and courses abroad. We give special attention to needed people and to those with fewer opportunities, aiming to them the chance to establish contact with other cultures, in order to help them to find ways to deal with their own problems and to break the existing prejudices.


