WHO WE ARE

The story of our reality begins in 1995 with the opening of "Archi Utopia Ilaria " the first residential care home for minors at risk in Campania region, in a historical moment in which there were only large institutions and orphanages for children, not responding to the basic needs of children. In the 2006, a new law fixed the closure of large kid care institutions and orphanages.

"Utopia Ilaria" (Portici) and "Utopia Luana" (San Giorgio a Cremano), host young boys and girls 12 /18 aged, away from their families by order of the Juvenile Court, or by executive decree in accordance to the art. 403 of the Italian Civil Code. Causes of withdrawal are different types of abuse and maltreatment (such as sexual abuse, abandonment, physical abuse, neglect, parental mental disorder, parents in prison).

On the Juvenile Law Court's authorization, our young can have a continuation in our care homes up to 21 years.

Then, Shannara guests young girls coming from the international prostitution trafficking (East Europe and EECA countries), offering residential care and rehabilitation project, supporting and accompanying them during the criminal trial against their exploiters.

Then, we also host unaccompanied foreign young people (Africa-Lampedusa Emergency) who arrived in Italy illegally. For all foreign children, a path of social integration is guaranteed, such as : procedures for issuing a temporary resident permit, Italian language course, the recovery of the skills of secondary school achievement and the starting of vocational courses.

We design and manage a range of preventive services for adolescents and youth (16-25 years) in a range of the entertainment area such as cultural exchanges with European and local organizations; aggregation youth center; different art activities.

MINORS CARE HOME (UTOPIA LUANA & UTOPIA ILARIA)

Our residential care homes offer reception, care, protection and education to young 12 /18 aged, with up to 21 years if hereinafter authorized by the Juvenile Law Court.

Residential services are provided for 365 days a year and for 24/24 hours.

Our care homes can host up to 4 young boy in Utopia Ilaria and up to 8 young girl in Utopia Luana.

The minors are sent by social services and / or by the Law Court on a specific request to take charge of a residential care project of temporary separation from the family on the basis of civil and / or administrative action, or taken from their familiar surroundings and / or environmental violence and / or child abuse, neglect state, family discomforts and / or behavioral problems.

The work team (manager, psychologist, educators) is focused on achieving and maintaining a welcoming and familiar atmosphere, the basic element to contain instances of affective and socio-relational of our minors. Individual Educational Programme (P.E.I.) is a personal project developed by our team along with the social worker and with the minor himself.

The latter, in fact, is the active protagonist of his own life project , which is verified from time to time and designed according to his needs and wishes. Constant and indispensable work is carried out from the complex network of social workers along with the origin municipality committee of the minor, the Juvenile Law Court, the local schools of our municipality, his parents/relatives (if they are still the legal tutors) and the different realities that come in various capacities in the care of the minor.

Depending on the case, the approximation to the family of origin is programmed in different ways such as planned protected meetings(usually in our care homes at the presence of the Supervisor and the psychologist); the outputs of a few hours with parents and planned re-entry in family on the weekend. This work is fundamental to understanding the resources of the family of origin and the effects it has on the minor's psychophysical balance.

We accommodate also children with mild or moderate cognitive disability by responding to their daily needs such as socio-educational, rehabilitative and / or healthy.

Shannara's mission is to protect the rights of minors and the activation of pathways for sustaining their growth and helping them to achieving personal and social autonomy.

AIMS :

Supporting the growth of minor entrusted to taking care of emotional and social relations, to promote inclusion and social integration (schooling of school and / or vocational); encourage, where possible, reconciled, and / or reintegration into the family of origin; enhancing its resources; to promote self-care and the caring of the environment; the internalization of values and founding principles of democratic coexistence; develop the ability to make independent and responsible choices. In addition, we push them into recreational activities for inclusion such as: sports, music and theater. Our minors also collaborate into the organization events/projects to promote children's rights and they are involved in all the activity that Arciragazzi Portici plan into the "Youth in Action program as organizer or sending organization.

RESULTS :

Shannara has about 160 individual complete projects as credits. Among these, there is the insertion of a offender minor (first case) under arrest at our facility.

Shannara is accredited for the obliged training course to get the degree in education at University Institute Suor Orsola Benincasa in Napoli and at Institute Cortivo in Padova for professional training courses.

ADULT FEMALE UNEASINESS (UTOPIA ELODIA)

Founded in 1995 as support activities for children's parenting received in our residential house, it was transformed into a woman's counseling center. Services for the adult distress' Italian offer to adults and / or foreign, for contingent situations of hardship, living in conditions social vulnerability. The overall objective of this type of service is to provide emergency responses with respect to the satisfaction of basic needs or necessity, but in the medium - long term is also to build pathways of autonomy or freedom from difficult conditions through the design of individualized paths inclusion and social integration with operations support and psychological care and social services, employment and integration support for autonomy. The Study Centre "Utopia Elodia" promotes, by an activity of information, the awareness of the phenomenon, and a culture on human rights and gender equality, through training and sensitivity to the problem.

ARCIRAGAZZI PORTICI "UTOPIA ATTANASIO"



Arciragazzi is a national association founded in the 1981, which promotes the Rights of Children and of Adolescence promulgated by ONU (20 November 1989) and ratified by the Italian Parliament on May 27, 1991.

It ensures the value and the quality of life of children and adolescents.

Arciragazzi use non-formal education as a method of first impact: these methods are fundamentally guided by the language of game, universally recognized as the most natural stimulus to the participation of children and young people.

It is used to define the game as a simple recreation moment, as a rash or something to entertain the kids for a short time. These images disfigured much of the game. we must give dignity to the game and enjoy them with a non-compulsory and passive participation, but with a curious, interesting and constructive participation.

The game is organized in the best way to interact with the city, kids needs to think about transforming it in a unifying experience to design the future. Arciragazzi so considers the game, a powerful tool for civic and cultural growth, and promotes the direct participation of children and young people in the development and management of projects, activities and discussions with the public authorities, schools and with Italian and European institutions.

Our target are children and adolescents (ages 6-18) with family problems, personality, school drop-out and social exclusion.

The staff includes also some volunteers.

AIMS:

- To promote the game in town squares and a culture of "Fit for Children";
- Promote and encourage the interpersonal dynamics with particular attention to multi-ethnic, generational, gender integration;
- Propose activities that enhance the participation of children;
- Support awareness campaigns and socially relevant initiatives, in cooperation with similar associations and government institutions;
- Promote voluntary service;
- Support the family and school to be an alternative educational in the leisure activities.
