AREAS OF CONTEMPORARY RESEARCH FOCUS



Youth Crime

Providing an insight into the regulation, control and punishment of young people in society whilst focusing on the Contemporary Issues in Criminology by examining and evidently exploring issues of social control such as mass incarceration, juvenile delinquency, mediation, etc.



Justice

Past and ongoing research has resulted in the deep understanding of the operation of the local and EU criminal justice system and the relationship between punishments and crime prevention. Some of our Dept.'s most notable activities in this area focus on the challenging problems relating to harmful behaviours in society whilst assessing a range of constructive solutions.



Media in Contemporary Society

The role of contemporary media in either our shaping perceptions of the social world, or acting as a mirror reflecting the world back to us, is a question that has been hotly debated in our days.
Furthermore, new media is often a focus of anxiety associated with declining moral standards, and dangerous for young minds in particular.

Crime, Media and Popular Culture

Popular culture today
engages in accessible ways
with issues intimately
associated with criminology
a sit represents powerful
resources of meaning,
narrative and imagination in
society and express a
myriad of assumptions,
political perspectives and

imaginings of 'reality'.
Subsequently, media
representations of crime have
tended to be examined in three
distinctive ways. Firstly,
whether violent depictions of
crime causes criminal conduct
in real life. Secondly, whether
the news media create moral
panics and fosters public fear.

Finally, more recent development relate to a broader consideration of how crime and punishment have been consumed, imagined and represented in popular culture.

Our team's focuses specifically on contemporary theories, analyses and debates to explore the intertextual loop between crime, media and popular culture and the blurring of boundaries between fact, fiction and entertainment.



International Relations and Human Rights





Exploring the importance of law, norms and values in the existing international order and their relevance to, and the role of, legitimation in international relations. Further to this end deeper inquiry is often made into the developing role of international legal and judicial frameworks.

The role of a variety of actors – including individuals, transnational and other corporations, non-governmental organisations, social movements, international and regional organisations and states - concerned with human rights issues at national, regional and global levels are being constantly examined and contextualised through investigation of the relevant frameworks and structures within which they function.

Moreover, work in this area has also been dedicated in exploring the ways in which digital media present these socially evolving issues within the transforming mediums in which we communicate in contemporary society.


Such research moves away from common-sense views about human rights, and considers an in depth social science analysis that can provide a nuanced understanding of questions of impact and audience response.

"Examining the nature of the international order, the relationship between human rights and state sovereignty, and the key problematic of intervention in case of violations of rights."


ADDITIONAL AREAS OF RESEARCH




Development of terrorism utilising new technology; terrorism, the media and public opinion; origins of terrorism; public policy remedies and international cooperation; security policy and global public health.



Social Psychology:


