Please briefly present your organisation	<p>350 Sicilia is the first local group of 350.org in Italy, part of the global movement pushing the world beyond fossil fuels and toward climate justice. We are a youth-led and autonomous organisation working at the local level, grounded in the belief that real change in Europe starts from empowered communities.</p> <p>Sicily is one of Europe's most climate-vulnerable regions, and we work to educate local communities, raise awareness, and ultimately encourage public authorities to take part in climate action and do their part.</p> <p>Our team is mainly composed of young people aged 18 to 35, reflecting a Gen Z-driven movement aiming to build a youth-led community who wants to promote youth representation in local climate dialogues.</p> <p>By combining care for our land with a heterogeneous international identity, 350 Sicilia aims to be a local hub for climate action and youth empowerment, connecting Sicily to broader European climate initiatives.</p>

We collaborated with associations, schools, and local communities to deliver knowledge on climate change and highlight the importance of climate action in Sicily.</p> <p>We have also organized creative art workshops for children in disadvantaged neighborhoods of Catania, teaching sustainable art practices that reuse simple discarded materials. In addition, we actively participate in practical environmental activities, such as beach clean-ups, to protect nature and public spaces.</p> <p>Through all these activities, young people develop skills in leadership, creativity, and civic engagement, while contributing directly to climate awareness, social inclusion, and community well-being.</p>
