

# ERASMUS + So far

## OUR MISSION

Report CEDIF 2018 : " In 2018, no less of 341 000 childrens in France are the subject of measures of protection set up by the services who name « the protection of chilhood ». Among them, a little more than of half (52 %) are placed outside the family circle. "Brigitte Bourguignon, then a French MP, handed over a report damning le system of placement in France : the homeless are 26% old childrens placed by the State. In addition, a non-anecdotal proportion of children in care are victims of sexual touching of domineering violence. Finally, the majority are tossed between several families until they come of age. The subject of childrens placed in host family is still very marginal : they are low visibility, no platform of expression, and , despite the two proposed reports, one by CEDIF, then the other by Mrs. Brigitte Bourguignon, current Deputy Minister, the new legislation introduced in France is not progressive and does not represent a possibility of major change.

## WHAT ABOUT EUROPE ?

What are their good practices? Do they have better results to offer for young people in care?These are all questions that deserve answers, with the aim of providing a strong and joint response to the distress of tens of thousands of children in the European Union.



# OUR 2024 GOALS
