



CONCEPT NOTE

1. Context

Sport is not only a tool but a reflection of society. In last years xenophobia is growing in sports.

Already in the UNESCO report "color, what color ?, Report on the fight against racism and discrimination in football "published in 2016 establishes a series of essential points that can be extrapolated to other sports:

- The concept of "us" and "them" that is implicit in the competition between two teams, which favors racism processes
- a large international legal context in the fight against racism and
- inoperation in the application of that legislation.

These elements of the report, as well as the daily reality in our activities, have shown us that there is no protocol for REAL application of that legislation signed by countries and federations. That fact is producing a situation of defenselessness and, instead of serving sport to fight inequalities, it is being a framework for the use and benefit of racist positions.

In the new Erasmus + Sport programme wthis project matches with **horizontal priority**: Inclusion and diversity in all fields of education, training, youth and sport and **Sport specific priority**: Combatiing violence and tckling racism, discrimination and intolerance in sport

2. Summary of the project

The project aims to provide intelectual outoputs in the form of protocols and recommendations to institutions and federations of real application of existing legislation.

For this, the project is based on three pillars:

Sports lawyers

Federations / professional clubs

Grassroot clubs and organizations fighting discriminastion in sports
