BACKGROUND AND EXPERIENCE

Bartin Directorate of National Education is an institution in the provincial organization of the Ministry of National Education within the structure of the Republic of Turkey. The legal authority, duties and responsibilities of the Bartin Directorate of National Education have been determined on the basis of the Constitution of the Republic of Turkey in particular, the Basic Law of National Education No. 1739 and the Decree Law No. 652 on the Organization and Duties of the Ministry of National Education. Our Directorate, which has a structure established in line with the Constitution, is responsible for the execution of the duties in the provincial organization of the Ministry of National Education and the realization of the state's policies under the governor's office. In this sense, our Directorate is primarily responsible to the governor's office, which is the representative of the state, government and ministries in the provincial organization. The Ministry of National Education has responsibilities such as fulfilling the responsibilities undertaken on behalf of the state, monitoring, evaluating and developing the units affiliated to it within the framework of the basic principles of National Education in line with Laws, Decrees, Regulations, Directives, Circulars and Orders.





What are the activities and experience of the partner organisation in the areas relevant for this project?

Bartin Directorate of National Education an association responsible mainly for education and training of children, teenagers, adults as well as children and teenagers that are in need of special education incorporates kindergartens, primary schools, secondary schools, anatolian high schools, anatolian technical and vocational high schools, multi-programme high schools, fee-paying schools and adult education centers.

Specific projects Bartin Directorate of National Education has been working on since 2011 are various. Some of these projects applied for Erasmus Programme are ''Come on for Common Nature'', ''Healthy Living Young People of Europe'', ''One Step Forward with Technology'' and ''Never Give Up! Love Your School, Life Will Be Better!''. Last two applications on Erasmus+ Programme are School Education Accreditation submitted by European Union and Vocational Education and Training Accreditation applied in October 2021 both of which aim to strengthen the European dimension of teaching and learning by promoting values of inclusion and diversity, tolerance, and democratic participation, by promoting knowledge about shared European heritage and diversity and by supporting development of professional networks across Europe.

Directorate of National Education has directors, teachers, and students. There is a division of labor in the research and development unit where Erasmus+ projects are carried out.
