D. BACKGROUND AND EXPERIENCE				



Please briefly present the partner organisation.	Koning Kevin is a non profit organisation acknowledged by the Flemish Government as Youth Work. Our purpose is to stimulate and encourage a responsible, playful and animated attitude in children and youth. We organise activities which focus quite a lot on creativity. We include music, visual arts, media, movement, theater, game-methods and the development of social competences. We work with a staff of 9 people and more then 250 volunteers
What are the activities and experience of the organisation in the areas relevant for this application?	We provide training to youngsters who want to work with youth on a voluntary basis. Therefore we have our own series of courses and we provide internships for them in our own organization. We provide training and education to a wide range of youth-organisations and schools. During the summer we organise summer camps for childeren en younsters from the age of 3years until the age of 26years. The camps have a strong focus on creativity and personal development and are guided by our volunteers. All volunteers are all trained by Koning Kevin. The organisation has a large tradition in experimenting and working with art education, game-methods and the development of social competences.
What are the skills and expertise of key staff/persons involved in this application?	For every project we compose a group of volunteers who will (toegther with the project-manager) be in charge of the project and make sure the project stays on the right track. By the formation of the group, we take into account: the background and experience of every member, their personal motivation, their competences and the complimentarity with other group members. Those volunteers are coached and guided by Lowiese Broes, who works at Koning Kevin in the function of education- and projectmanager. Her daily tasks are the development of new educational methods and developing new project.
