We include music, visual arts, media, movement, theater, game-methods and the development of social competences. We work with a staff of 9 people and more then 250 volunteers</p>
<p>What are the activities and experience of the organisation in the areas relevant for this application?</p>	<p>We provide training to youngsters who want to work with youth on a voluntary basis. Therefore we have our own series of courses and we provide internships for them in our own organization.</p> <p>We provide training and education to a wide range of youth-organisations and schools.</p> <p>During the summer we organise summer camps for children en youngsters from the age of 3years until the age of 26years. The camps have a strong focus on creativity and personal development and are guided by our volunteers. All volunteers are all trained by Koning Kevin.</p> <p>The organisation has a large tradition in experimenting and working with art education, game-methods and the development of social competences.</p>
