- A deeper exploration of the 'holistic' and 'systemic' concepts
- Agreement on the mentoring process.

The “Hellenic youth Workers Association” was established in 2017 by Greek youth workers. The Association's primary goal is to enable, develop and strengthen knowledge of youth work and its practice to achieve recognition of the profession of Youth Worker in Greece. As youth work is not recognized yet in Greece, there are no professional pathways for practitioners in the youth sector and no official Greek wording for the profession.

The **Hellenic Youth Workers Association (HYWA)** is advocating the development of a sustainable youth strategy and the recognition of Youth Work in Greece. The **HYWA** acknowledges the passionate and dedicated commitment to youth work and aims that youth workers in Greece will have a credible professional career pathway.

The **Hellenic Youth Workers Association** is working towards:

- Creating a framework for the recognition and certification of the profession of youth work in Greece and its contribution to young people for their development.
- *Fostering the growth of the professional practice, quality and identity of youth work*
- The development of professional educational pathways for youth workers
- For the contribution to the development of a national youth strategy
- The development of new practices and methods for its members and their target groups with a focus on digital Youth Work.
- *Promoting the value and ensuring the quality of youth work practices*

The collective capacity of the association is very high in terms of project management, implementation and development of sustainable and innovative results. The **HYW Association** has 50 members from all over Greece. It is governed by the Board and the General Assembly and has its own Scientific Committee which analyses, suggests and develops formal documents, research and curriculums tailor-made for the youth workers in Greece.

In 2005, the European Commission's Directorate-General for Education and Culture ('DG EAC') set up the Expert Group in the Youth Policy Field. The mandate of this expert group was and still is to support DG EAC in the general and strategic development of youth policy initiatives. A range of sub-groups have been set up over the years, under the umbrella of the main expert group.

In 2021, a sub-group on youth work ('the sub-group') is being launched to support DG EAC in developing deliverables requested by the Council. The main expert group's task shall be to assist DG EAC in the preparation of non-legislative proposals and policy initiatives in the field of youth in relation to youth work.

The sub-group's task was to provide advice and expertise specifically for the youth work area, in accordance with the invitation addressed to the Commission by the Council (see above), in the elaboration of the following outcomes:

- Recommendations for the setting up and development of the above-mentioned digital platform, taking into account the needs of the youth workers and the youth work community of practice, as well as for sharing information, knowledge and good practices, and for engaging in cooperation and peer-learning;
- Accompanying and advising on the development of the platform, and on its dissemination to a wide audience of practitioners.
